

## **MINNESOTA 2019 BULLDOGS FOR VETERANS**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER.

1. Eligibility: The Bulldog For Veteran ("Campaign") is open only to legal residents of Minnesota who: (i) have reached the age of 18; and (ii) live in the State of Minnesota prior to the start of the Entry Period (defined below). Void elsewhere and where prohibited by law. Lonely Acres Bulldogs ("Campaign Administrator" & "Sponsor") and any other PayItForward contributors, their respective parent, subsidiary and affiliated companies, distributors, retailers, dealers, sales representatives and licensees, and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of the Campaign (collectively, "Promotion Parties"), and their immediate family members (i.e. parent, child, sibling and spouse of each) and those living in the same household of each are not eligible to enter or win. Other eligibility requirements and conditions of participation are set forth below in these official rules for the Campaign ("Official Rules").

Details of circumstances are a very important and convincing part of submission. Send a maximum of three [3] photos) and an essay (each, an "Essay") (collectively, your Photo(s) and Essay may be referred to as your "Submission") explaining (in English) why your family member or friend or you yourself could benefit from the companionship of a Bulldog Emotional Support Dog; and (b) provide your complete name, email address, phone number, and mailing address; (ii)

signify your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules(collectively, your Submission and Form may be referred to as your "Entry"). In order to be eligible, your Submission must comply with the Submission Requirements set forth below. In order to be eligible, your Entry must be submitted and received in compliance with these Official Rules during the Entry Period (as determined by the Sponsor at its sole discretion). All Entries are subject to a review by Campaign Administrator and Sponsor prior to posting online (see below for details).

By uploading your Entry, you agree that your Submission conforms to the Submission Requirements set forth below and that Campaign Administrator, in its sole discretion, may remove your Entry (including your Submission) and disqualify you from the Campaign if it believes, in its sole discretion, that your Entry fails to conform to these Official Rules, including, without limitation, the Submission Requirements. THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON/EMAIL ADDRESS/ PER RESIDENCE. Your Entry will be rejected if (in the sole and absolute discretion of the Sponsor) your information is not fully completed(including uploading your Submission) and submitted during the Entry Period.Use(or attempted use) of multiple name,identities, Facebook Accounts (defined below), email addresses and/or any automated system to enter, Vote (defined below) or otherwise disrupt this Campaign is prohibited and is grounds for disqualification by the Sponsor. The Released Parties (defined below) are not responsible for late, lost,misdirected, delayed, incomplete or incompatible Entries or Votes. All Entries and Votes are subject to verification at anytime.

The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) to participate in this Campaign.

Failure to provide such proof in a timely manner may result in disqualification. The sole determinant of the time for the purposes of a valid Entry in this Campaign will be the Campaign server machine(s).

#### 4. Submission Requirements:

Any Entry which the Campaign Administrator or Sponsor, in its sole opinion, deems to be inappropriate for publication will not be considered or displayed and the corresponding entrant will be disqualified. Without limiting the generality of the foregoing and for greater certainty, a Submission cannot: (i) be sexually explicit or suggestive, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, contain nudity or any materially dangerous activity; (ii) promote alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message; (iii) be obscene or offensive, endorse any form of hate or hate group; (iv) defame, misrepresent or contain disparaging remarks about Sponsor or its products, or other people, products or companies; (v) contain trademarks, logos or trade dress owned by others, or advertise or promote any brand or product of any kind, without permission, or contain any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses; (vi) contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images published on or in websites, television, movies or other media); (vii) contain materials embodying the names, likenesses, photographs, or other indicia identifying any person, living or dead without permission; (viii) communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and (ix) depict, and cannot itself, be in violation of any law.

By submitting an Entry, each entrant represents and warrants that: (i) his/her Submission is the sole and original creation of the entrant or entrant owns all rights in the Submission and has not been copied in whole or in part from any other work (including that his/her Submission is substantially different from any other work, including, without limitation, any other

(ii) waives all moral rights in and to his/her Submission in favor of the Sponsor; and (iii) agrees to release and hold harmless the Released Parties from and against any and all claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trade-mark infringement or any other intellectual property related cause of action that relate in any way to the Submission. Without limiting the generality of the foregoing, each entrant acknowledges that his/her Submission may be posted on the Sponsor's website(s) (including, without limitation, the Website), in the Sponsor's sole discretion.

Posting of a Submission is not an indication that the corresponding entrant has won a prize or is otherwise eligible for a prize.

5. Any waiver of any obligation hereunder by Sponsor does not constitute a general waiver of any obligation to entrants. Campaign Administrator and Sponsor reserve the right, in their reasonable discretion, at any time, to request that any entrant resubmit his or her Entry prior to any voting or judging period. 6. The Bulldog Puppy shall be determined by Lonely Acres Bulldogs at its sole discretion. The puppy shall be brought to the home of the Chosen Veteran or Active Military Person, which must be located within the limits of Minnesota, USA. No substitution, cash redemption or transfer of the Bulldog Puppy is permitted. Arrangements for execution of the Puppy will be performed after winner validation. At Sponsor's discretion, if the Puppy is unclaimed, it may not be awarded.

7. Conditions: Campaign Administrator, Sponsor and Reviewer's decisions are final in all matters relating to this Campaign. The potential Bulldog Puppy winner will be notified by telephone, email, regular mail or overnight mail (using the information provided in his/her Entry), and will be required to complete, sign and return a declaration of eligibility, liability release, and

where lawful, a publicity release within a stated amount of time (collectively, the "Confirmation Documents"). If the properly executed Confirmation Documents are not received by the date stated on the notification, or if any notification is returned as non-deliverable, or if the potential winner is found to be ineligible or not in compliance with these Official Rules, or does not return such other releases as deemed necessary by Campaign Administrator, such potential winner will be disqualified and, at Campaign Administrator's discretion, an alternate potential winner may be selected.

The Released Parties are not responsible for any change of email address, mailing address and/or telephone number of entrants. The Released Parties assume no responsibility for lost, late, misdirected, stolen, illegible, inaccurate, damaged or incomplete Entries, Votes or other communications, non-delivered or postage due mail, failure or unavailability of electronic equipment, communications or internet connections, or other errors, failures or malfunctions of any kind. Entries or Votes submitted by automatic, programmed or like methods will be disqualified. Improper, incomplete, mutilated and illegible Votes or Entries will be disqualified. This Campaign is subject to all federal, state, and local laws. If, in Campaign Administrator's sole opinion, the Campaign is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Campaign as contemplated by these Official Rules, the Campaign Administrator reserves the right to modify or terminate the Campaign in a manner deemed reasonable by the Campaign Administrator, at the Campaign Administrator's sole discretion. In the event of cancellation of the Campaign, Campaign Administrator will randomly award the Bulldog Puppy from among all eligible, non-suspect Entries received prior to cancellation. Campaign Administrator reserves the right to disqualify any individual who tampers with the entry process or acts in a disruptive or unfair manner. In the event of a dispute regarding the identity of the person submitting an Entry, Entries

will be declared made by the person's name submitted at the time of entry (and an entrant may be required to provide proof of identity in a form deemed satisfactory by the Campaign Administrator at its sole discretion).

8. Choice of Law and Jurisdiction: This Campaign is offered only in Minnesota, USA and is governed by the laws of the State of Minnesota. By entering, entrants irrevocably consent to the sole and exclusive jurisdiction of the courts of Mower County for any action, suit or proceeding arising out of or relating to this Campaign.

10. Releases: Without limiting the generality of the foregoing and for greater certainty, as a condition of entering this Campaign, entrants agree (and agree to confirm in writing if requested by the Sponsor): (a) to release, discharge and hold harmless the Released Parties from and against any and all liability, loss, injuries or damages associated with this Campaign and, if applicable, incurred with respect to the awarding, receipt, possession, and/or use or misuse of the Bulldog Puppy, or the use of any Entry (including any Submission); (b) under no circumstances will an entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (c) all causes of action arising out of or connected with this Campaign, or any prize awarded, shall be resolved individually, without resort to any form of class action; and (d) any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs.

By accepting the Bulldog Puppy, the winner grants permission for Sponsor and their agents to use his/her name, video/photograph, voice and other likeness, for advertising and/or publicity purposes in any and all media now

known or hereinafter invented without territorial or time limitations and without additional compensation.

Lonely Acres Bulldogs, Leah Lysne, hereafter referred to as the Sponsor, Breeder and/ or Lonely Acres Bulldogs, hereby agree to transfer ownership and possession of the animal described below to, \_\_\_\_\_, hereafter referred to as the Recipient(s), Bulldog for Veteran Campaign 2019. The previously described dog will hereafter be known as "bulldog", "puppy", or "dog" with the following conditions and warranties:

Any bulldog given LIMITED AKC is given on a spay / sterilization agreement to Recipient with the terms as outlined below. Limited AKC bulldog is given as pet and refers to the dog being given as a pet and companion only. The bulldog can never be bred and no guarantees of breed standard quality are implied.



## **General Terms**

1. Both parties, without any emotional or mental reservations whatsoever, are freely entering into this contract.
2. Contract/agreement/warranties are only implied between the Breeder and the original Recipient, NOT a third party.
3. The Sponsor certifies that, upon receipt, the dog is in good health and has been immunized and wormed according to the accompanying health record of said Bulldog. This dog has the following conditions:

---

and those are excluded from any guarantee and is not valid to reject the puppy due to these conditions.

### **Possession / Living Arrangements/ Welfare:**

1. Recipient agrees that bulldog is to be kept in the Recipient's living quarters and be treated as part of the family. Extensive time in outside areas, garage, tied up outside or kenneled outside is not allowed. Extensive time would be considered more than 30 minutes at a time or more than 2 hours unattended in a 24 hour period.
2. Recipient is solely approved in this contract, and therefore agrees bulldog is for them and lives in Recipient's home, no where else.
3. Recipient will not let bulldog run free and unattended, except in a fenced yard or enclosure. Recipient agrees to never chain, tether, or tie out dog unsupervised or for more than 10 minutes at a time. Supervising party must be a responsible adult.
4. Recipient agrees to provide proper and adequate shelter and fresh clean water at all times.
5. Recipient agrees to proper daily exercise and socialization of bulldog in amounts appropriate to the age of bulldog. During young months of structural development the dog will not be allowed to run / exercise unsupervised with larger canines, allowed to jump up or down from heights, go distance running / jogging, or be subject to go up and down flights of stairs.
6. If Recipient cannot provide proper training for bulldog, Recipient agrees to get a more qualified professional if needed.
7. Recipient agrees to feed bulldog in proper amounts, a quality, premium dog food. Experienced raw feeders, can feed raw.
8. Recipient hereby certifies that is bulldog is not made by Recipient as an agent for any other person or entity and further agrees that the bulldog

shall not be given to any agent, broker, pet store, breeder, or animal research facility.

9. The death, injury or loss of bulldog due to theft, carelessness, recklessness, abuse, neglect, heat stroke or accident will not entitle the Recipient to any compensation from the Sponsor.

10. Any proof of abuse or neglect, the Sponsor and / or state has full rights to press criminal charges on Recipient(s).

### **Vaccinations / Veterinary Care / Care:**

1. The health of bulldog is good to best the Breeders' knowledge and belief at the time of this contractual agreement, unless previously noted above in the general terms. Regardless, no guarantees are expressed or implied or are made by Sponsor that bulldog will remain free from injury, illness, or other health conditions once bulldog has left the Sponsors' care or throughout bulldog's lifetime.

2. The Recipient is responsible for seeking prompt and appropriate veterinary care in the event of injury or illness of bulldog. Recipient is responsible for any and all veterinary expenses incurred for bulldog while in their care.

3. Sponsor does not require a set protocol as Recipient can choose to go by Recipient's veterinarian recommendation or choose to believe in method of not over-vaccinating. Sponsor is not liable for negative consequences in either case.

4. Recipient understands that puppies are NOT fully vaccinated until all 3 rounds of puppy shots are complete. Recipient will therefore limit bulldogs exposure to other pets and public places until bulldog has received all 3 rounds of vaccinations and is at least 6 months of age.

5. In the event that bulldog requires vet care for any reason and vet care is not provided, which most times will lead to further complications. Health guarantee in this contract is voided. However, sales agreement/contract is not and remains in full force.

### **Limited AKC Spay / Neuter/ Sterilization**

1. Limited AKC/ pet only bulldog must be spayed or neutered between 12 & 18 months of age, no sooner or later. This is after the day the bulldog turns 12 months\_\_\_\_\_ and before bulldog turns 18 months of age\_\_\_\_\_.

2. Veterinarian verification of spay/neuter is required to be sent to Sponsor by U.S. mail within 15 days of procedure by Recipient. Proof of spay / neuter must have veterinarian name, address, phone number, procedure performed, date of procedure, dog's name, and if possible bulldog's

microchip number or photo of bulldog. Recipient agrees to have their veterinarian release any needed information and health records of bulldog to Sponsor.

3. Recipient is aware that any limited registration bulldog that has been used for breeding will automatically void the health guarantee part of this contract. Any bulldog male or female that is found to be bred prior to spay or neuter; or is bred in breach of contract that was given limited AKC is liable to pay a fine of \$10,000 plus and additional liquidated damages of \$1,500 per puppy produced by dog.

4. Extensions to spay or neuter are only offered on a case to case basis and are short-term only. Sponsors must be contacted if an extension is needed and give consent, and Sponsors are not obligated in any way to grant an extension.

### **Health Guarantee**

Not Applicable

### **Reservation of Rights:**

1. Sponsor reserves the right to enforce this contract in order to protect the welfare of bulldog given by them to Recipient.

2. The Recipient expressly grants permission for the Sponsor or their designees(s) to visit the Recipient's home at any time to verify the welfare of bulldog.

3. The Recipient further expressly agrees that the Sponsor may repossess bulldog upon any evidence of neglect and/or abuse or upon any breach of this agreement, at no expense to the Sponsor and with no refund of any monies to the Recipient.

4. If the Sponsor does ask for bulldog to be returned to the Breeder, due to evident neglect, abuse, and/or breach of contract, bulldog shall be returned within 48 hours.

5. Should the Breeder need to seek legal action against the Recipient for violations of this agreement, the Recipient hereby agrees that he/she/they will assume any and all attorney costs, court fees, and other legal fees or additional expenses incurred in the process of enforcing this contract or of repossessing bulldog.

### **First Right of Refusal (Recipient Not Keeping Bulldog)**

1. If at any time, for any reason, the Recipient finds that they are unable or unwilling to continue to care for bulldog, the Recipient agrees to immediately contact the Sponsor FIRST. The Recipient is required to inform

the Sponsor of such an issue as soon as possible.

2. The Sponsor always gets first right of refusal upon decision made by Recipient to re-home Bulldog.

3. If Sponsor is for whatever reason unable to take bulldog back, the Sponsor must approve in writing the new home for bulldog before being placed by Recipient. Such permission shall not be withheld unreasonably, but Sponsor has the exclusive right to determine the suitability of any potential subsequent owner.

4. Recipient agrees that at the time of transfer of bulldog back to the Sponsor that all records will be turned over to the Sponsor which include, health, medical, AKC registration, and microchip registration. All necessary paperwork will be signed as needed transferring ownership back to the Sponsor.

5. Recipient agrees to either transport bulldog to Sponsor, or pay 100% of the shipping/transportation fees to Sponsor's location. Sponsor is willing to meet up to 6 hours from Sponsor's home.

6. Recipient agrees that at no time will they, without prior written permission from the Breeder, sell, give, trade, adopt, place, lease, foster, or re-home bulldog to any person, business, place or organization including allowing bulldog to be taken to a shelter or be sent to a rescue without the express written consent of the Sponsor. This provision includes Recipient trying to use the term "having someone watch" dog for an extended period of time that would include 30 days or more in a 180-day period outside of Recipient's home listed in this contract.

7. If Bulldog is found to have been sold, placed, or given away without the Sponsor's consent, the Sponsor can take legal action and Recipient of bulldog will be responsible for all expenses incurred including legal fees and any additional expenses.

**Required Updates or Notifications:**

1. Recipient is required to at least send yearly updates for first 2 years concerning bulldog. These updates should include: a) at least 2 clear photos of bulldog, one from the side to show structure and one from the front with face facing camera. (would love to see as many as you want to send!)

2. An explanation of any health or temperament issues. (This helps us with our breeding program.)

3. General update of how bulldog is doing.

4. Recipient also agrees that Sponsor may use any photos of bulldog sent to us on our website or social media pages to give other potential Recipients an idea of what we produce here at lonely acres English Bulldogs.

5. If the Recipient moves from the address stated above and/or changes phone number, the Recipient shall, within 30 days of address and/or phone number change, provide the new address and/or telephone number to the Sponsor via email, mail, or phone.

6. If the Breeder moves from their location or change phone number, the Breeder shall, within 30 days of address or phone number change, provide the new address and/ or phone number to the Recipient either by email, mail, phone, or updating our information on our website or social media pages that are public for all our Recipients to check for updates.

**Breach and Termination of Agreement:**

1) This Contractual Agreement shall be binding on & insure to the benefit of the parties hereto & their respective heirs, legal or personal representatives, successors, & assigns including all provisions that logically ought to survive shall survive.

2) The gross breach by Recipient of any of the terms of this agreement shall be grounds for immediate action without refund, at the sole discretion of the Sponsor. Sponsor may in addition to the remedy of termination, sue for and recover from Recipient actual damages, including reasonable attorneys fees and costs caused by any such breach, including, but not limited to, liquidated damages of \$2,000 for each puppy produced out of any breeding of said bulldog not allowed by this agreement. In the event of any gross breach of contract, Recipient does hereby agree that the Sponsor may also take immediate legal possession of the dog without any monetary reimbursement to the Recipient. The failure of Sponsor to enforce any provision of this agreement shall not constitute a waiver of Sponsor's right to enforce any other provision of this agreement or to sue for breach of that or any other provision hereof.

3) Health guarantees that are voided due to breach of contract and/or Recipient not completing Recipient's duties and/or responsibilities, do not release the Recipient(s) to any of the contract agreements contained in this contract. All restrictions do still apply and are legally enforceable.

4) The Recipient agrees that if any provision of this contract is found to be illegal or unenforceable, then that provision shall be severed and the remaining provisions of this contract shall have full force and effect.

5) This agreement is hereby entered into and wholly executed in the State of Minnesota, Mower County and litigation arising from any possible breach of this agreement shall be adjudicated in the State of Minnesota, Mower County.
